The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 02 Grants for State Plan Schemes (Sub-Major Head); 796 Scheduled Tribes Sub Plan (Minor Head); 34-NRHM-RCH Flexible Pool (Sub-Head); 34.04- RCH Flexible Pool (New); .34.04.31-Grants-in-aid General in Demand No.47 Health & Family Welfare during 2014-15 (Plan).
