Sir,

I am directed to convey the sanction of the President to the payment of Grant-in-aid of Rs.26.34 lakh (Rupees twenty six lakh thirty four thousand only) to the State of Madhya Pradesh towards the first instalment for the implementation of the National Oral Health Programme for the year 2014-15.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance(Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GOI.
4. The State shall ensure that 25% 10% of its share based on release of funds by GOI is credited to appropriate accounts.
5. The State shall follow all the financial management systems under NHM and shall submitted Audit Reports, Utilization Certificate, Quarterly Summary on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
7. The expenditure covered by this sanction is debitable to Major Head "3601 Grant-in-Aid General to State Governments(Major Head) "; 02263 Public-Health Prevention & Control of Diseases(Minor Head); 09-Flexible Pool for Non-Communicable Diseases(New); 0906-National Oral Health Programme(New); 090631 Grants-in-Aid -General(Plan) for the year 2014-15.
