
Subject: Family Welfare Programme - Release of second instalment (2) of grants-in-aid for implementation of Infrastructure Maintenance, a Centrally Sponsored Plan Scheme during 2014-15 – **Revamping of Urban F.W. Centres - STSP (Scheduled Tribe Sub Plan)**

Sir,

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.9.15 lakhs** (Rs. nine lakh and fifteen thousand) only to the State of **Orissa** towards the second instalment (2) of grants-in-aid for implementation of Infrastructure Maintenance (Urban Revamping Scheme), a Centrally Sponsored Plan Scheme during 2014-15.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
3. The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 02 - Grants for State Plan Schemes (Sub-Major Head); 796 - Scheduled Tribe Area Sub-Plan (Minor Head); 33 - FW-Direction & Administration (Sub-Head); 33.04-IM-Revamping of Urban Family Welfare Centres; 33.04.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2014-15.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
