The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Fund Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- 7. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
