Sir,

I am directed to convey the sanction of the President of India for the payment of Rs. 10,28,000 (Rupees Ten Lakhs & Twenty Eight Thousand Only) to the State of Assam towards the grants-in-aid Under National Programme for Health Care of the Elderly (NPHCE) NCD Flexible Pool – **SCSP (Scheduled Cast Sub Plan)** for the financial Year 2014-15.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. State government will furnish Utilization Certificate(s) in original along with Audited Statement of Accounts duly signed by the Audit officer/Authorized Chartered Accountant and countered signed by the competent authority of the state government.
5. The State shall ensure that 10 % of its share based on release of funds by GOI is credited to appropriate accounts.
6. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Fund Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
7. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

9. The expenditure covered by this sanction will be met from the funds provided under Demand No-47, Major Head – 3601- Grants-in-aid to State Governments (Major Head); 02789 - Scheduled Castes Sub Plan (Minor Head) 3510- Flexi Pool for Non-Communicable Diseases –Health Care for Elderly (New) ; 351031- Grants –in-Aid under Health & Family Welfare during 2014-15 (Plan).

10. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
