

3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. State government will furnish Utilization Certificate(s) in original along with Audited Statement of Accounts duly signed by the Audit officer/Authorized Chartered Accountant and counter signed by the competent authority of the state government.

5. The State shall ensure that 25% of its share based on release of funds by GOI is credited to appropriate accounts.
6. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Fund Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
7. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
8. The fund shall be utilized solely for the implementation of NPHCE in accordance with the Operational Guidelines issued under the Programme.
9. The expenditure covered by this sanction will be met from the funds provided under Demand No-47, Major Head – 3601- Grants-in-aid to State Governments (Major Head); 02796 - Scheduled Tribe Sub Plan (Minor Head) 3510- Flexi Pool for Non-Communicable Diseases Health Care for Elderly (NPHCE (New) ; 351031- Grants in-Aid General during 2014-15 (Plan).
10. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
