Subject: F.W Programme- Release of instalment(up to 75% of allocation) of grants-in-aid for implementation of Pulse Polio Immunization Programme during 2014-15- General

Sir,

I am directed to convey the sanction of the President to the payment of Rs.12,13,00,000/- (Rupees Twelve crore and thirteen lakh) only to the Bihar State for the implementation of SNID/NID rounds likely to be held during 2014-15 under Pulse Polio Immunization Programme. No round-wise fund will be released separately.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. 10(1) - PF-1/76 dated 22nd January, 1977 and is to be paid in cash.

3. The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grant in -aid to State Governments (Major Head); 02- Grants for State Plan Schemes (Sub Major Head); 02.246 – F. W.-Reproductive and Child Health (Minor Head); 01.03- Pulse Polio Immunization Programme ;01. 03. 31- Grant in aid-General in Demand No. 47- Department of Health and Family Welfare during 2014-15.

4. The grant in aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance Department of Expenditure vide Letter No. 2 (90)-P-II/66 dated 9.10.1966.

5. A total sum of Rs.345,87,00,000/-(cash/Kind) has been provided under the head indicated in Para 3 above, out of which a sum of Rs.197,99,48,650/- (including the above sanctioned amount of Rs.12,13,00,000/-) has been incurred. A sum of Rs.147,87,51,350/- is still available under the head concerned.

6. This sanction issues with the concurrence of Finance Division vide Dy.No. C-1592 dated 22.10.2014.
