- 6. The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- 7. The Expenditure covered by this sanction will be met from the funds provided under Demand No.47 3601-Grants in Aid to State Government (Major Head), 02263-Public Health-Prevention and Control of Diseases (Minor Head), 08-Flexi Pool for Communicable Diseases-New, 0803-National TB Control Programme EAC-New, 080331-Grants in Aid General for the year 2014-15.
