- 6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.

The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 02 Grants for State Plan Schemes (Sub-Major Head); 796 Scheduled Tribes Sub Plan (Minor Head); 34-NRHM-RCH Flexible Pool (Sub-Head); 34.05- Mission Flexible Pool (New); .34.05.35- Grants for Creation of Capital Assets in Demand No.47 Health & Family Welfare during 2014-15 (Plan).
