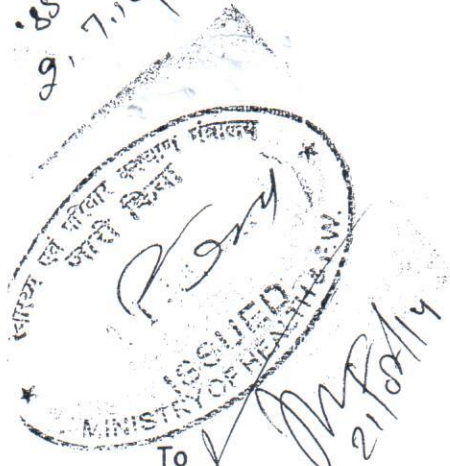

Subject : Sanction of funds for the year 2014-15 under National Programme for Prevention & Control of Fluorosis to various States.

Sir,

In supersession to this Ministry's earlier sanction letter of even number dated 3rd July, 2014 on the above subject, I am directed to convey the sanction of the President to the payment of Grant-in-aid of Rs.15,00,000/- (Rupees fifteen lakh only) to Government of Gujarat for the implementation of the National Programme for Prevention & Control of Fluorosis(NPPCF) for the year 2014-15 in Banas Kantha district. namely Karauli, Chittaurahgarh, Ganganagar, Jhalawar & Jhunjhunu.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance(Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GOI.
4. The State shall ensure that 25% of its share based on release of funds by GOI i.e. Centre:State ratio being 75:25 is credited to appropriate accounts.
5. The State shall follow all the financial management systems under NHM and shall submitted Audit Reports, Utilization Certificate, Quarterly Summary on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
