Subject: F.W Programme- Release of funds up to 75% of the allocation of Grants in aid for implementation of Pulse Polio Immunization Programme during 2014-15- NE STATES (General).

Sir,

I am directed to convey the sanction of the President to the payment of Rs.6,65,14,000/- (Rupees Six crore Sixty five lakh and fourteen thousand) only being 75% of the Budget allocation to the four States, as detailed in the table below, for the implementation of NID rounds likely to be held during current financial year 2014-15 under Pulse Polio Immunization Programme. No round-wise fund will be released separately.


