- The expenditure covered by this sanction will be met from the funds provided under Major Head - 3601- Grants-in-aid to State Governments (Major Head); 02 - Grants for State Plan Schemes (Sub-Major Head); 796 - Scheduled Tribes Sub Plan (Minor Head); 34- NHM-RCH Flexible Pool (Sub-Head); 34.05- Mission Flexible Pool (New); .34.05.35- Grants for Creation of Capital Assets in Demand No.47 - Health & Family Welfare during 2014-15 (Plan).
