
Subject:- Release of Grants for creation of capital assets under NUHM Flexible Pool (General) for the year 2014-15.


- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-1/76 dated 22nd January, 1977 and is to be paid in Cash.
- The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- The State shall ensure that 10% or 25% of its share based on release of funds by GOI is credited to appropriate accounts.
- The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- The expenditure covered by this sanction will be met from the funds provided under Demand No. 47, Major Head-3601-Grants-in-aid to State Governments, Sub-Major Head-02-Grants for State Plan Schemes, Minor Head-02246-Family Welfare - Reproductive & Child Health, Sub-Head-02-National Urban Health Mission-Flexible Pool (New), 0201-National Urban Health Mission (New), 020135-Grants for creation of capital assets during 2014-15 (Plan).



8. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.11/66 dated 9.10.1966.


