

I am directed to convey the sanction of the President of India to the payment of ₹.2,26,000/- (Rupees Two Lakh and Twenty Six thousand only) to the UTs of Puduchery towards the grants for creation of Capital Assets for NUHM Flexible Pool during 2014-15 ✓

- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1) P-1/76 dated 27th January, 1977 and is to be paid in cash.
- The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, Govt.
- The State shall ensure that 25% of its share based on release of funds by GOI is credited to appropriate accounts.
- The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- The expenditure covered by this sanction will be met from the funds provided under Demand No. 47, Major Head-3602-Grants-in-aid to Union Territory Governments, Sub-Major Head-02-Grants for State Plan Schemes, Minor Head-02789-Scheduled Caste Sub Plan, 34-FW-RCH (New), Sub-Head-3406-National Urban Health Mission-Flexible Pool-National Urban Health Mission (New), 340635-Grants for creation of capital assets during 2014-15 (Plan).
- The grants in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (30)-P.11/66 dated 9.10.1966.
- This sanction issues with the concurrence of Finance Division vide Dy. No. C-1965 dated 18th December, 2014.


