- 3. Three years' experience in the specialty after obtaining the Post-graduate degree or five years' experience in the speciality after obtaining the Post-graduate Diploma.

#### 4. **Age Limit**:

Up to 45 years. Relaxable for Government Servants, Scheduled Castes, Scheduled Tribes and Other Backward Classes candidates. Upper age limit up to 5 years is relaxable for Scheduled Castes, Scheduled Tribes and 3 years in the case of OBC candidates.
