I am directed to convey the sanction of the President to the payment of Rs.10,13,000/- (Rupees Ten lakh thirteen thousand) only being 75% of the Budget allocation to Puducherry as detailed in the table below, for the implementation of NID rounds likely to be held during current financial year 2014-15 under Pulse Polio Immunization Programme. No round-wise fund will be released separately.

- The expenditure covered by this sanction will be met from the funds provided under Major Head 3602- Grant in -aid to Union Territory Governments (Major Head); 02- Grants for State Plan Schemes (Sub Major Head); 02.246 - F. W.-Reproductive and Child Health (Minor Head); 01.03- Pulse Polio Immunization Programme; 01. 03. 31- Grant in aid-General in Demand No. 47- Department of Health and Family Welfare during 2014-15.
- The grant in aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance Department of Expenditure in terms of Ministry of Finance Letter No. 2 (90)-P-II/66 dated 9.10.1966.
- A total sum of Rs.16,32,00,000/- (cash/Kind) has been provided under the head indicated in Para 3 above ,out of which a sum of Rs. 3,70,93,000/- (including the above sanctioned amount of Rs.10,13,000/-) has been incurred. A sum of Rs12,61,07,000./- is still available under the head concerned.
