I am directed to convey the sanction of the President to the payment of Rs.4,48,83,000/-(Rupees Four crore forty eight lakh and eighty three thousand only to seven States, as detailed in the table below, for the implementation of NID rounds likely to be held during current financial year 2014-15 under Pulse Polio Immunization Programme. No round-wise fund will be released separately.

A sum of Rs.33,19,52,600/- is still available under the head concerned.

6. The sanction order is being issued in accordance with Rule 205 to 215 of General Financial Rules. This is a Plan recurring grant.
