**TERMS & CONDITIONS FOR CONTRACTURAL APPOINTMENT OF CONSULTANT  
(OBSTETRICS & GYNECOLOGY)**

1. The appointment is purely on contract basis initially for a period of six months (can be extended up to total of one year after satisfactory performance) or till regular incumbent joins whichever is earlier with effect from the date joining. The appointment can be terminated at any time (On either side) by giving 7 (Seven) days notice or by paying one month salary, without assigning any reason or on failure to complete the period of Six month's to the satisfaction of the competent authority.
2. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/ additional allowance will be admissible in case of such assignment.
3. The appointee shall not be entitled to any benefit like Provident fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government servants appointment on regular basis.
4. Non-practicing allowance will not be admissible.
5. The appointee will not be granted any claim or right for regular appointment to any post under Central Health Service.
6. Only consolidated remuneration will be admissible. No dearness allowance and other allowance as are admissible to the Central Government servants shall be admissible.
7. The appointee shall be on the whole time appointment of the institution and shall not accept any other appointment, paid or otherwise and shall not engage himself/ herself in private practice of any kind during the period of contract.
8. Consultant (O & G) will ensure rational prescription of drugs (as per evidence based medicines) to the patients and will prescribe generic medicines only, as far as possible.
