The expenditure covered by this sanction will be met from the funds provided under Major Head - 3601- Grants-in-aid to State Governments (Major Head); 02 - Grants for State Plan Schemes (Sub-Major Head); 244 - FW-Direction & Administration (Minor Head); 01-FW-Infrastructure Maintenance; 01.07-Training of MPWs (Male); 01.07.31- Grants-in-aid - General in Demand No.47 - Health & Family Welfare during 2014-15.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.


