FW Bureaux; 33.01.31- Grants-in-aid - General in Demand No.47 - Health & Family Welfare during 2014-15.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.


