

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 02 – Grants for State Plan Schemes (Sub-Major Head); 796 - Scheduled Tribe Sub-Plan (Minor Head); 33 - FW-Direction & Administration; 33.03-IM– Urban FW Centres; 33.03.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2014-15.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.

5. This sanction issues with the concurrence of Finance Division vide Dy. No. C-2008 dated 29.12.2014.


