

The expenditure involved will be met out of the approved Budget Estimates under Demand No. 47 Dept. of Health-FW; 3601-Grants-in-aid to State Governments (Major Head); 02-Grants for State Plan Schemes (Sub-Major Head), 02789-Scheduled Caste Sub Plan (Minor Head0; 35-Public Health Prevention and Control of Diseases, ₱503-Flexible Pool for Communicable Diseases NVBDCP-Cash Grants GC (New); 350331 Grants-in-aid-General for the financial year 2014-15 (Plan).

- No utilization is pending against Chattisgarh Government.
- 7. Principal Accounts Office may issue an advice to Reserve Bank of India, Central Accounts Section, Nagpur from affording credit of Rs. 15,62,000/- (Rupees Fifteen Lakhs Sixty Two Thousands only) to the State Government of Chattisgarh with copies endorsed to Accountant General and Finance Department of State Government of Chattisgarh.
- The pattern of assistance or rules governing such grants-in-aid have received the approval of Ministry of Finance as required under Govt. of India Decision (1) below Rule 20 of Delegation of Financial Powers.
