

Subject: Release of Grants-in-aid for Mission Flexible Pool - SCSP (Scheduled Castes Sub-Plan).

Sir.

I am directed to convey the sanction of the President of India to the payment of Rs. 0.44 Crore (Rupees Forty Four lakhs only) to the State of Odisha towards the grants-inaid for Mission Flexible Pool during 2014-15.

- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
- 3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- 4. The State shall ensure that 25%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
- The State shall follow all the financial management systems under NHM and shall 5. submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- 6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- The expenditure covered by this sanction will be met from the funds provided under Major Head - 3601- Grants-in-aid to State Governments (Major Head); 02- Grants for State Pian Schemes (Sub Major Head); 02.789 - Scheduled Castes Sub Plan (Minor Head); 34- FW - Reproductive & Child Health; 34.05- NRHM - RCH Flexible Pool - Mission Flexible Pool (New); .34.05.35- Grants for Creation of capital assets, in Demand No.47 - Health & Family Welfare during 2014-15 (Plan).
- 8. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10,1966.
