- 3. The State shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, Gol.
- 4. The State shall ensure that 25%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
- 5. The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- 6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- 7. The expenditure covered by this sanction will be met from the funds provided under Major Head = 3601- Grants-in-aid to State Governments (Major Head); 02 Grants for State Plan Schemes (Sub-Major Head); 789 Scheduled Castes Sub Plan (Minor Head); 34- NRHM-RCH Flexible Pool (Sub-Head); 34.04- RCH Flexible Pool (New); 34.04.31- Grants-in-aid General in Demand No.47 Health & Family Welfare during 2014-15 (Plan).
