- The accounts of the Grantee institutions shall be open to inspection by the sanctioning authority and will also be liable for statutory audit by the Comptroller and Auditor General of 4. India as per the norms of General Financial Rules.
- The grant-in-aid is subject to the following:-5.
- The funds may be deposited in already opened Bank Account for the purpose, Interest (i) earned should be credited into Government of India account as revenue.
- The funds sanctioned will be utilized for the purpose for which it is sanctioned; (ii)

- (iv) The Government of Tamilnadu will furnish an undertaking to bear the additional expenditure, if any, on account of salary of the staff and their training under the scheme;
- (v) This shall be subject to fulfillment of various terms and conditions specified and mutually agreed upon in the MOU.
