- 2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash. Re-appropriation order enclosed.
- The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, Gol.
- 4. The States shall ensure that 25% / 10% of its share based on release of funds by GOI is credited to appropriate accounts.
- 5. The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- 6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- 7. The release of funds sanction in within 15% limit of payment during March 2015 for the financial year 2014-18.

- 8. The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 02-Grants for State Plan Schemes (Sub Major Head); 02.789 Scheduled Castes Sub Plan (Minor Head); 34-FW Reproductive & Child Health; 34.04- NRHM-RCH Flexible Pool RCH Flexible Pool (New); .34.04.31- Grants-in-aid General in Demand No.47 Health & Family Welfare during 2014-15 (Plan). Copy of re-appropriation order is enclosed.
- 9. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
