- The States shall ensure that 25% / 10% of its share based on release of funds by GOI is credited to appropriate accounts.
- The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- The release of funds sanction in within 15% limit of payment during March 2015 for the financial year 2014-15.
