The expenditure involved will be met out of the approved Budget Estimates under Demand No. 47 Dept. of Health-FW; 3601-Grants-in-aid to State Governments (Major Head); 02-Grants for State Plan Schemes (Sub-Major Head), 02796 Scheduled Tribe Sub Plan (Minor Head); 35 Public Health Prevention and Control of Diseases, 3503 Flexible Pool for Communicable Diseases NVBDCP- Cash Grants GC (New); 350331 Grants-in-aid-General for the financial year 2014-15 (Plan).

- Principal Accounts Office may issue an advice to Reserve Bank of India, Central Accounts Section, Nagpur from affording credit of Rs. 26,74,000/-(Rupees Twenty Six lakh Seventy Four thousand only) to the State Government of Gujarat with copies endorsed to Accountant General and Finance Department of State Government of Gujarat.
