- (ii) The grant-in-aid is subject to the conditions and principles laid down in Rule 206 to 215 of the General Financial Rules, 2005 and instructions there under, modified from time to time as well as other specific conditions that may be circulated from time to time.
- (iii) The accounts of the grantee institution/ organisation shall be open to inspection by the senctioning authority and audit both by the Comptroller and Auditor General of India
