The expenditure is debitable to Demand No.47 Department of Health & Family Welfare 3601 Grants-in-aid to State Governments (Major Head) 02796 Tribal Area Sub Plan (Minor Head) 2806 Human Resources for Health & Medical Education - Establishing New Medical Colleges (Upgrading District Hospitals) 280635 Grants for creation of capital assets (Plan) for the financial year 2014-15.

3. The grant-in-aid is subject to the following terms and conditions:-

- (i) The grant-in-aid should be utilized for the purpose for which it has been sanctioned.
- (ii) The grant-in-aid is subject to the conditions and principles laid down in Rule 208 to 215 of the General Financial Rules, 2005 and instructions there under, modified from time to time as well as other specific conditions that may be circulated from time to time.
- (iii) The accounts of the grantee institution/ organisation shall be open to inspection by the sanctioning authority and audit both by the Comptroller and Auditor General of India under the provisions of the CAG (DPC) Act, 1971 and internal audit by Chief Controller of Accounts of the Ministry, whenever the institution is called upon to do so.
- (iv) The grantee institution is not authorized to divert the grants or entrust the execution of the scheme for which the grant is made for another purpose. In case of it not being in a position to execute or complete the assignment, it should forthwith refund to the Central Government the entire amount of the grant received by it.
- (v) Institution receiving funds under Pradhan Mantri Swasthya Suraksha Yojana (PMMSY) will not be eligible for funding under the present scheme.
