Sub.: **Release of First Installment of Grants in Aid for Flexible Pool for communicable Diseases to Karnataka State under Revised National TB Control Programme during the year 2014-15.**


Sir,

I am directed to convey the sanction of the President of India for release of an amount of ₹.19,43,99,000/- (Rupees nineteen crore forty three lakh ninety nine thousand only) to the State of Karnataka towards first Installment of Grants-in-Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme during the year 2014-15 as lump sum for undertaking various activities for implementation of RNTCP in the State.

- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-1/76 dated 22nd January, 1977 and is to be paid in Cash.
- The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- The State shall ensure that 25% or 10% (as applicable) of its share based on release of funds by GoI is credited to appropriate accounts.
- The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
- The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- The Expenditure covered by this sanction will be met from the funds provided under Demand No.47 - 3601-Grants in Aid to State Government (Major Head), 02263-Public Health-Prevention and Control of Diseases (Minor Head), 08-Flexi Pool for Communicable Diseases-New, 0803-National TB Control Programme EAC-New, 080331-Grants in Aid General for the year 2014-15
- The Grants-in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 09.10.1966.
