- 6. The sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
- 7. The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 02- Grants for State Plan Schemes (Sub Major Head); 02.796 Scheduled Tribes Sub Plan (Minor Head); 34- FW Reproductive & Child Health; 34.04- NRHM- RCH Flexible Pool RCH Flexible Pool (New); 34.04.31- Grants-in-aid General in Demand No.47 Health & Family Welfare during 2014-15 (Plan).
