The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 02- Grants for State Plan Schemes (Sub Major Head); 02.246 FW Reproductive and Child Health Project (Minor Head); 01- NRHM-RCH Flexible Pool (New); 01.04- RCH Flexible Pool (New); 01.04.31- Grants-in-aid General in Demand No.47 Health & Family Welfare during 2014-15 (Plan).
