

The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grant in -aid to State Governments (Major Head); 02- Grants for State Plan Schemes (Sub Major Head); 02.246 - F. W.- Reproductive and Child Health (Minor Head); 01.03- Pulse Polio Immunization Programme ;01. 03. 31- Grant in aid-General in Demand No. 47- Department of Health and Family Welfare during 2014-15. **Copy of Budget FW Re-Appropriation Order : No. G.23011/2/2014-Budget9NRHM0 dated 19.th June 2014.is also enclosed.**

4. The grant in aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance Department of Expenditure in terms of Ministry of Finance Letter No. 2 (90)-P-II/66 dated 9.10.1966.
