

Sub: Release of First Installment of Grants in Aid for Flexible Pool for communicable diseases to Gujarat State under Revised National TB control Programme during the year 2014-15.

Sir,
I am directed to convey the sanction of the President of India for release of an amount of **Rs 15,77,00,000/-** (Rupees fifteen crores seventy seven lakhs only) to the State of Gujarat towards first installment of Grants-in-Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme during the year 2014-15 as lump sum for undertaking various activities for implementation of RNTCP in the State.

- The above amount is in accordance with the instruction issued by the Ministry of Finance (Plan finance Division) vide their O.M No. 10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in cash.
- The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- The State shall ensure that 25% or 10% (as applicable) of its share based on release of funds by GoI is credited to appropriate accounts.
- The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly summary on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
- The sanction order is being issued in accordance with Rule 206 to 215 of General Finance Rules, 2005.
- The Expenditure covered by this sanction will be met from the funds provided under Demand No. 47- 3601- Grants in Aid to State Government (Major Head), 02263-Public health- Prevention and Control of Diseases (Minor Head), 08- Flexi Pool for Communicable Diseases- New, 0803- National TB Control Programme EAC- New, 080331- Grants in Aid General for the year 2014-15..
- The Grants-in-Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No. 2 (90)-P.II/66 dated 09.10.1966.
