The undersigned is directed to refer to the above mentioned subject and to say that in pursuance of Rule 13 and 14 of the Rules for Combined Medical Service Examination (CMSE), 2011, the Union Public Service Commission has released a Reserve List of 34 candidates (General-6 and OBC-28) for appointment from the Reserve List of CMSE 2011 as per Annexure-I.

2. After assessing the requirement of candidates of various cadres (Departments) on the basis of CMSE 2011, the following candidates from the Reserve List of CMSE 2011 are allocated to Ministry of Railways, Ministry of Defence and Ministry of Health (CHS). Allocation of the candidates has been made keeping in view the number of vacancies intimated by the cadre, rank obtained by the candidates and preference(s) given by the candidates. List of candidates allocated to Railways and Defence is enclosed as Annexure II.

3. The character and antecedents of these candidates have not been verified. The cadre authorities are, therefore, requested to complete the formalities relating to verification of their character and antecedents. Medical Examination Report of the candidates are enclosed in their dossiers. Some of the candidates have not completed their medical examination formality (where medical examination report is not available). In such cases, their detailed medical examination may be got conducted by the prescribed Medical Board. These candidates are eligible for apptt. only after they are declared FIT by the Medical Board.

4. Copies of the Other Backward Classes(OBC) certificates submitted by the candidates claiming to belong to OBC have been added to their respective dossiers. The claims of the candidates who belong to OBCs have been accepted on the basis of original certificates submitted by them. As the cases have occurred in the past where candidates obtained OBC certificates even though they do not actually belong to these categories, cadre authoroties may, if they consider it necessary, further verify the authenticity of these documents before making offer of appointment.

There may be some cases where though OBC certificates have been issued to the candidates, the "Creamy Layer" status may be doubtful keeping in view the income/status of the parents of the candidates as per the declaration of the candidates vide Col. 16(k) in the Detailed Application Form. It is, therefore, requested that the cadre authorities may in such cases ensure that such candidates do not attract "Creamy Layer" provision and offer of appointment to these candidates may be made after the cadre authority satisfies itself in this respect also.

- 5. A list of 19 candidates whose cases are **Provisional** is enclosed as **Annexure III**. The documents shown against the Roll Nos. of these candidates (marked Provisional) may please be obtained from them (in original alongwith the photocopies) and sent to the UPSC immediately for verification and record. The offer of appointment to these Provisional candidates should not be issued till the UPSC verifies the documents and intimate to the cadre authority.
- 6. A list of 05 candidates whose cases are **Conditional** is enclosed as **Annexure IV**. The documents shown against these conditional candidates need not be sent to UPSC and the same, as and when received from the candidates, may be verified by the respective cadres (Departments) to which the candidate is allocated. Their appointment, if they are otherwise eligible, need not be held up due to this reason.
- 7. The concerned cadre should satisfy themselves before the candidates are appointed that they have completed the Compulsory Rotating Internship. The copies of offer of apptt., as and when issued to them may invariably be endorsed to UPSC. UPSC may also be informed as soon as the candidate joins against the offer of apptt.
