**Sub.: Release of First Installment of Grants in Aid for Flexible Pool for communicable Diseases to Goa State under Revised National TB Control Programme during the year 2014-15.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of Rs. 34,00,000/- (Rupees thirty four lakh only) to the State of Goa towards first Installment of Grants-in Aid for Flexible Pool for Communicable Diseases under Revised National TB Control Programme during the year 2014-15 as lump sum for undertaking various activities for implementation of RNTCP in the State.

- The above amount is in accordance with the instruction issued by the Ministry of Finance (Plan Finance Division) Vide their O.M. No.10(I)-PF-1/76 dated 22th January, 1977 and is to be paid in cash.
  - The State shall not make any changes in allocation or re-appropriations among different components/activities without approval of the MoHFW, Gol.
  - The State shall ensure that 25% of its share based on release of funds by Gol is credited to appropriate accounts.
  - The state shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMP/SOEs and Statement of Funds Position, showing unspent Balances, funds released as advances, interest earned on unspent balance as and when due.
  - The Sanction order is being issued in accordance with Rule 206 to 215 of General Financial Rules, 2005.
  - The Expenditure covered by this sanction will be met from the funds provided under Demand No.47 - 3601 -Grants in Aid to state Government (major Head), 02 - Grants for States Plan Schemes (Sub-Major Head) 02796 Scheduled Tribe Sub Plan (Minor Head ) 35- Public Health-Prevention and Control of Diseases 3504-Flexi Pool for Communicable Diseases-New-National TB Control Programme EAC-New, 350431-Grants in Aid General for the year 2014-15.
  - The Grants -in Aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 09.10.1966.
