5. The Grant-in-aid is subject to the following:-

- i) The funds sanctioned will be utilised for the purpose for which it is sanctioned.
- ii) Expenditure statement, utilisation certificate and audited accounts of the fund sanctioned be submitted to this Ministry within 12 months of release of funds.
- iii) A certificate regarding satisfactory completion of the process of procurement and installation of the equipments be sent to this Directorate.
- iv) After receipt of certificate regarding the completion of the process of procurement and installation of the equipment, an inspection of BRD Medical College, Gorakhpur, U.P will be carried out by the officials of this Directorate/Ministry.
- v) The State Govt. will pass on the funds sanctioned to the BRD Medical College, Gorakhpur, U.P. within three weeks after the date of the release of the same under intimation to this Directorate.
