The admission to post graduate Degree/Diploma Courses will be governed by the concerned Chapters Ordinances (Academic) (Chapter XLIII to L) for all academic matters, during the period of admission as Jun Residents. The terms and conditions of admission shall be as follows:

1. TENURE:

- i) The tenure of those admitted to post graduate degree course will be 36 calendar months from the date admission and shall be 24 months for those admitted to diploma courses.
- ii) The report of progress will be monitored by the Chairman of the department and will be forwarded Dean, Faculty of Medicine every three months.
- Admission to Degree/Diploma Courses will initially be provisional and may be cancelled at any time owing to reasonable occasion:
- (a) By the AMU, without any previous notice if the Chairman of the department/Dean, Faculty of Medicir are satisfied, on Medical evidence, that the student is unfit and is likely to continue unfit for considerable period by reason of ill health for the discharge of his/her duties, PROVIDED ALWAY and binding on him/her.
- (b) By the AMU, Aligarh or its authorized officer without any previous notice if the post graduate student i found guilty of non-performance, derelication of duties, misbehavior, indiscipline and non-punctuality or any other misconduct as laid down in the AMU Students Conduct and Discipline Rules 1985, in force at present or subsequently enforced.

2. STIPEND:

- i) The amount of monthly stipend shall be fixed in accordance with the notification from the UGC.
- An amount of Rs. 1000/- will be deducted from the first payment as security deposit and the same will be retuned after completion of course on receipt of clearance certificate from the Dean of the Faculty of Medicine.
- iii) If the post graduate student is suspended from the duty in connection with any investigation into his/her conduct, he/she shall not be entitled to any stipend during such period of suspension but shall receive a suitable amount as may be decided by the Dean, Faculty of Medicine.

 The total period of payment of stipend from the date of first admission to post graduate Diploma course shall be 24 months and Degree course shall be 36 months irrespective of the case of change of specialty if any, from Diploma to Degree course of from Degree course to other Degree course.

3. WORKING HOURS:

Hours of work will be from 8:00 a.m. to 5:00 p.m. for clinical departments. Besides night calls. OPD and Emergency calls to Casualty Section will have to be attended as arranged by the Chairman of department. The daily work and teaching programme will be arranged by the Chairman of the department and any additional work due to exigencies in the department may be assigned by the Chairman of the department. Hours of work for non-clinical department shall be fixed by the Chairman of the departments.

14 days Casual Leave in a calendar year which can neither be accumulated nor combined with Earned

16 days Earned Leave to JR-I and 22 days Earned Leave to JR-II and JR-III in a calendar year which can be accumulated up to 36 days.

Note:

Leave account and attendance of PG students (who are working as Junior Residents) will be maintained by the Chairman of the department, and a copy of monthly attendance (indicating leave availed) will be forwarded to Dean, Faculty of Medicine.

MEDICAL CARE: 4.

Medical Care will be the same as are available to the other students of the University.

CERTIFICATION: 5.

Certificate of completion of course will be issued, only after receipt of a satisfactory work and conduct report from the Chairman of the department concerned and after obtaining a 'No Dues Certificate' fro the concerned University offices, Dean's Office, Faculty Library, Dept./Hospital/Hall of residence etc.

- OBSERVANCE OF RULES AND REGULATIONS: 6.
- Every post graduate student shall be required to abide by all rules and regulation and orders, prescribed i)'' for them fro time to time by the University Faculty of Medicine, JN Medical College Hospital.
- Every post graduate student shall devote his/her whole time in such duties as are prescribed in pursuance 'ii) . of his/her course of study and shall not engage himself/herself, directly or indirectly, in any private practice, trade business, occupation or other profession. Violation of rules shall be treated as misconduand shall make him/her liable to disciplinary action.
- 7., VERIFICATION:
