SPECIFIC INSTRUCTION FOR SC CANDIDATES:-

SC candidates from category rank numbers SC-1 to SC-351 are requested to report for counseling as per the Time Schedule mentioned above. **Advance reporting till the category rank No. SC-351 is not required.**

SC candidates from Rank Number SC-352 to SC-390 are requested to report at the concerned counseling venue on **03.08.2009** at **2:00 PM** for smooth conduct of counseling and to avoid non-availability of SC candidates. SC-391 onwards should come on 03.08.2009 at 9:00 AM. The Candidates who report in advance should make their own arrangements for stay nearby their counseling venue.

If SC candidates fail to report in advance, he/she will be marked absent and will forfeit the claim under All India Quota.

Important instructions:

❖ **Counseling will be held as per the Category Rank (UR/SC/ST/PH) only** and the seats will be allotted to the candidates as per the 2200 point Reservation Roster. OBC candidates should report for counseling as per their **UR Category rank.**

❖ Counseling venue will not be changed in the second round of counseling. Candidates must attend the counseling as per the venue mentioned in their Rank Letters.

❖ The candidates who were **absent** or **rejected** or **not joined** or **resigned after joining the seat allotted** in the 1st round of counseling will **NOT** be eligible for reallocation of the seats in the 2nd Round of counseling.

❖ Candidates from Rank No. **UR-1 to UR 1551, SC-1 to SC-351, ST-1 to ST-85** and **URPH-1 to URPH-10** for re-allocation must bring the Admission Slip, Admission Fee Receipts **in-original** and the **UNDERTAKING** proforma printed at Annexure XI of the Prospectus duly signed by the Principal/Dean of the admitted college alongwith a photocopy of Admit Card, Rank Letter duly attested by a Gazetted Officer. Candidates without **Original fee receipt** and **Undertaking Performa** for re-allocation will **NOT** be allowed.

❖ Counseling from Rank Nos. UR-1551 onwards and SC-352 to SC-420 will be held as per the 2200 Point Reservation Roster and candidates should bring all documents **in-original** as mentioned in page no. 36 of the Prospectus for verification during the counseling.

❖ **Under any circumstances candidates without original certificate shall NOT be allowed to participate in the counseling.**

❖ **Candidates who have taken admission and deposited their original certificate with the Institute/Universities and come for counseling with a certificate stating that "their original certificates are deposited with the Institute/University", will NOT be allowed to participate in counseling in any case.**

❖ **No authorization is allowed to appear for counseling until and unless the authorized representative should bring authentic proof/Medical certificate of his/her hospitalizations/mis-happening alongwith the original documents. However, Original allotment letter will be issued to the authorized representative only after when he/she will come along with the candidate.**

❖ **Counseling will be continued till the availability of MBBS/BDS seats.**
