

I am directed to convey the sanction of the President to the payment of grant-in-aid of **Rs.9.18 lakhs** (Rupees nine lakh and eighteen thousand) only to the **UT of Puducherry** towards the second instalment (1) of grants-in-aid for implementation of Infrastructure Maintenance (Direction & Administration), a Centrally Sponsored Plan Scheme during 2014-15.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
