Please read all the following instructions and Information Bulletin (Counseling)-2011 carefully before participating in the second round of UG Counseling 2011.

Please see this website notice regularly, (daily from 29 July 2011 till conclusion of counseling) for any changes/new information.

Specific Instructions for SC/ST/PH candidates

(1) SC/ST candidates Rank Number from **SC-284** and **ST-146** onwards should report **1 (one) counseling day in advance of their schedule date of counseling but not before 11.08.2011.** Advance reporting upto **SC-283, ST-145** and **PH Candidates** are not required as their counseling will be done as they appeared in the 1st Round of the counseling, as per above schedule.

(2) The candidates reported in advance may or may not get the seat allotted on the same day. If they do not get the seats allotted on the same day, they will be allotted the seats on the following day as mentioned in the schedule. Hence, they should make their own arrangements to stay for at least for 2-3 days in the city of counseling venue.

(3) If SC, ST candidate fail to report in advance, he/she will be marked absent and will not be considered for the counseling.

Important Instructions:

(4) **Counseling will be held as per the Category Rank (UR/SC/ST/PH) only.**

(5) All OBC candidates should report for counseling as per their **UR Category rank only.** The candidates who are eligible **only for OBC seats** will not claim for rest of the seats.

(6) **Counseling venue will not be changed in second round of counseling.**

(7) The candidates who were **absent** or **rejected** or **not joined** or **resigned after joining the seat allotted** in the 1st round of Counseling will not be eligible for re-allocation of the seats in the 2nd Round of Counseling.

(8) 2nd round of counseling for re-allocation for the candidates with Category Rank Nos. **UR-1 to 1504, SC-1 to 283, ST-1 to 145** will be held as they have appeared in 1st round of counseling. Interested candidates can change or retain their previous allotted college. There is no provision to surrender the previous allotted seats before the counseling committee in the counseling venue. UR-PH and SC-PH candidates will appear for counseling strictly as per above schedule.

(9) **Documents to be verified: At the time of counseling.**

(a) **For Re-allocation:**

(Candidates from Category Rank No. UR-1 to 1505, SC-1 to 283, ST 1 to 145, UR-PH-1 to 44, SC-PH-3).

(i) Admission Slip, (ii) Fee Receipts **in-original** and (iii) **UNDERTAKING** proforma printed at **Appendix-IV** of the Information Bulletin (Counseling)-2011 duly signed by the Principal/Dean of the admitted college alongwith a photocopy of Admit Card, rank Letter duly attested by a Gazetted Officer. **Candidates with Original UNDERTAKING Proforma signed on or after 29.07.2011 for re-allocation will be allowed. Please note that without this undertaking candidate will not be allowed to participate in 2nd round of UG Counseling 2011.**

(b) **For Fresh Candidates:**

(Candidates from Category Rank No.UR-1506 to 3820, SC-284 to 728, ST-146 to 243) as mentioned at Para (e) under sub-heading **“ALLOTMENT OF SEATS BY PERSONAL APPEARANCE (COUNSELING)”** of the Prospectus and under any circumstances without original certificates shall **NOT** be allowed to participate in the counseling for fresh allotment.

(10) Candidates who have taken admission from other than All India Quota and deposited their original certificates with the Institutes/Universities will **NOT** be allowed to participate in counseling in any case.

(11) No authorized representative is allowed to appear for counseling until and unless, such candidates fulfill the criteria as mentioned in Information Bulletin (Counseling)-2011 at Para 10(h).

(12) **Counseling will be continued till the availability of MBBS/BDS seats for allotment. There is a possibility that all available MBBS/BDS seats are exhausted before allotment of seats to all available candidates. In this situation some of the candidates may have to go back without allotment of MBBS/BDS seats for which Directorate General of Health Services will not be responsible in any manner.**
