

Regional Leprosy Training and Research Institute, Aska, Orissa.

This institute was established in the year 1977. At present there is 47 staff in position out of 67 sanctioned posts. It has a 50 beds hospital and average bed occupancy is about 50%. The institute provides both Outdoor and Indoor services to leprosy patients. The institute also works as a referral center for management difficult to diagnose leprosy cases, Skin smear examination and problematic, complicated and intractable cases of reaction and ulcers. Physiotherapy measures and MCR chapples are provided to the needy patients. Amputation and various other surgical procedures are carried out regularly and RCS (Reconstructive Surgery) camps have been done in the past. It also works as a nodal training and research center for the cause of leprosy elimination.
