1. The Particulars of Min. of Health & Family Welfare's functions & duties:

Regional Office for Health and Family Welfare, Bangalore is a subordinate office headed by the Regional Director under the administrative control of Min. of Health and Family Welfare/Directorate General of Health Services, Govt. of India. It consists of five units i.e., Family Welfare, Evaluation Team, National Vector Borne Diseases Control Programme, MOFRS under NVBDCP and Field Survey Unit. The functions of each unit is as follows:

- i) <u>Family Welfare</u>: It comes under the direct supervision of the Senior Regional Director. The functions of this unit is supervision, liason, and coordinating work for the various National Health and Family Welfare Programmes with State Government (Karnataka).
- ii) <u>Evaluation Team</u>: It consists of Evaluation Assistants under the direct supervision of Evaluation Officer. The Evaluation team evaluates the progress and achievements of the Family Welfare and MCH programmes in the state of Karnataka and Andhra Pradesh.
- iii) FIELD SURVEY UNIT: This unit is headed by Deputy Director who is assisted by Statistical Assistants and computors. This unit conducts surveys and studies in the State of Karnataka to collect specific information with regard to shortfalls in implementation of Health & Family Welfare programmes in order to initiate timely corrective measures. This unit also conducts studies with regard to health problems of the region with special reference to the health problems of backward and tribal communities. This unit provides training for para-medical staff as and when the Central Bureau of Health Intelligence allots the trainings.
- **National Vector Borne Diseases Control Programme:** It is under supervision of Chief Medical Officer. The Chief Medical Officer is assisted by Research Assistant, Senior/Junior Technicians, and Insect Collectors. This unit undertakes cross-checking of blood smears, takes up entomological work and assists in the training programme of vector bone diseases medical and para-medical staff of Government of Karnataka.

v) MOFRS: This unit is headed by Research Officer and he is assisted by Lab. Assistants. This unit conducts drug sensitivity studies for P.falciparum and P.vivax in the State of Karnataka, Tamil Nadul, Kerala, Goa and Union Territories of Pondicherry and Lakshadweep. It also involved with many field operations research activities including epidemiological investigations. The team also conducts malaria clinic and also assists in cross checking of blood smears.

2. Powers and duties of its Officers and employees:

As per instructions from Ministry/DGHS, the Senior Regional Director/Concerned Section Officers are empowered to make their programmes within their jurisdiction. Regarding their duties, all are discharging their respective duties as stated in item No 1

Evaluation Team: Evaluation Assistant-Evaluation Officer – Senior Regional Director- Chief Director Evaluation.
