

- The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 02 - Grants for State Plan Schemes (Sub-Major Head); 244 – FW-Direction & Administration (Minor Head); 01 – FW-Infrastructure Maintenance; 01.05-Training of ANM/LHVs (Sub Head); 01.05.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2014-15.
- The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
