

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 02 – Grants for State Plan Schemes (Sub-Major Head); 789 – Schedule Caste Sub Plan (Minor Head); 33 – FW-Direction & Administration (Sub-Head); 33.03 –I.M.-Urban FW Centres; 33.03.31- Grants-in-aid – General in Demand No.47 – Health & Family Welfare during 2014-15.
