

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.62.59 lakhs (Rs. sixty-two lakh and fifty-nine thousand) only to the State of **Manipur** towards the second instalment of grants-in-aid for implementation of Infrastructure Maintenance (Direction & Administration), a Centrally Sponsored Plan Scheme during 2013-14.
