I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.92.38 lakhs (Rs. ninety-two lakh and thirty-eight thousand) only to the State of **Manipur** towards the second instalment of grants-in-aid for implementation of Infrastructure Maintenance (Sub-Centres), a Centrally Sponsored Plan Scheme during 2013-14.
