

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.255.98 lakhs (Rs. Two crore fifty-five lakh and ninety-eight thousand) only to the State of West Bengal towards the first (3) & second (3) instalment of grants-in-aid for implementation of Infrastructure Maintenance (Urban Family Welfare Centres), a Centrally Sponsored Plan Scheme during 2013-14.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.

The expenditure covered by this sanction will be met from the funds provided under Major Head - 3601- Grants-in-aid to State Governments (Major Head); 04 - Grants for Centrally Sponsored Plan Scheme (Sub-Major Head); 789 - Special Component Plan for Schedule Castes (Minor Head); 04 - FW-Direction & Administration; (Sub-Head); 04.04 -I.M.-Urban FW Centres; 04.04.31- Grants-in-aid - General in Demand No.47 - Health & Family Welfare during 2013-14.
4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
