

I am directed to convey the sanction of the President to the payment of Grants-in-aid of Rs.556.82 lakhs (Rs.Five crore fifty-six lakhs and eighty-two thousand) only to the State of **West Bengal** towards the first (3) & second (3) instalment of grants-in-aid for implementation of Infrastructure Maintenance (Direction & Administration), a Centrally Sponsored Plan Scheme during 2013-14.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
